

Discussion on "Universality of affine and polynomial processes" by Christa Cuchiero

Want to model non-Markovian process (path-dependence) in an Itô-diffusion type of way.

Idea: Signature captures ^{all} information about a path. Look for

$$dX_t = b(X_t)dt + \sigma$$
